Directions to Tohickon Campground — 8308 Covered Bridge Road, Quakertown, PA, 18951

From PA Turnpike Northeast Extension Exit 32 Quakertown. Take Route 663 East to Route 313.

NOTE: Vehicles over 12 foot — Take Route 313 East Past Thatcher Road to Rt. 563 North. Rt. 563 North left onto Sterner Mill Road (at their signs) Go 25 yards. Right onto Richlandtown Road. Follow to Right onto Covered Bridge Drive.

Directions to the Rajah Shrine Complex, Maidencreek, PA: From the intersection of U.S. Route 222 and PA Route 73. Turn onto Route 73 West. Travel approximately 3/4 mile to Orchard Road. Turn left onto Orchard Road. Complex is on Right side of road.

Directions to Shady Oaks Campground -40 Round Barn Road, Newmanstown, PA:

From 1-78 W— Take Exit 17 for PA-419 toward Rehrersburg. Turn left onto PA-419 S/4 Point Road. Turn left onto PA-419S. Turn left onto W. High Street. Take the 1st right onto PA-419S/S 2nd Street. Continue to follow PA-419S. Turn left a N. Fort Zellers Road. Continue Straight onto S. Fort Zellers Road. Make a slight right onto Stricklerstown Road. Turn left onto Round Barn Road. Turn left onto Woods Lane.
