Hello from your 1st Vice President,

Madolyn and I are finally at home in Maine for the majority of days each week. We only spent a few weeks in Florida during March this year due to our busy schedule in Connecticut since Mid-October. The issue in Connecticut was due to a sewer main backup in the basement, which required most of the in-law apartment to be rebuilt and sewer line replacement. We attended Connecticut's OES Grand Chapter session shortly after returning home and then prepared for the NCT event schedule.

District 1 just finished our Friendship Rally campout May 16-19 at Travelers Woods in Bernardston, MA. Our District 1 chapters have a full schedule again this year.

Along with a committee, I have been working on updating the NCT Operations Manual. This update is required in order to be in-sync with our current bylaws. I'm hoping to get this completed and sent to the Board for approval before the Annual meeting.

As of the writing of this article, the 2025 Ballot results were made known. It was shocking to hear of the all-time low number of ballots returned!

Some of you may remember that we put out a message in N2C for interest in NCT historical items. These are items stored with Ray Geer and now we need to find a new home for storage. I was able to take some items from that storage. Most of what I have will be brought to the 60th International Rally. Some items were requested and other items which attendees may have interest in.

From the storage items, I picked up an old copy of N2C - March Ballot issue of 2005. Frank Bushwack (CT1, Ch 6) National President article: Frank's concern of 20 years ago, was that over 200 members were dropped in Dec 2004 due to non-payment of dues, and he wanted to understand the "drastic drop" in membership. Some questions he presented: "Was there a way this could have been prevented? Did we try everything? Did the Chapters personally contact each member to ascertain the problem?" "We cannot continue to exist with such a small membership that decreases in numbers like this." In 2004: We had 2,689 members; 103 Chapters

Frank stated that "This year will be a very challenging time for Board members" and himself. I said "Wow" - reading Frank's N2C Article. That was 20 years ago, and we are asking similar questions and looking at our club's existence the same way they did back then! President Cliff Fromm has some ideas for membership discussions planned at the International Rally this July. Please bring ideas and thoughts for this discussion.

With that said, we need to give credit to all the past and current NCT leadership who brought us through the past 20 years!

Madolyn and I hope to see many of you at the 2025 International Rally in Orrstown, PA to support National President Cliff and his wife Ann. They have worked hard to plan a fun, relaxing, enjoyable Rally. I will be installed as National President and would like to see many of you there.

Please keep our members in our prayers who have medical issues or ongoing issues. Reach out with a card, email, or a call to let them know you are thinking of them.

Previously there was a proposal set forth to help save NCT. There were members who opposed this proposal, and it did not go forward. This is all well and good, but we need to figure out how we proceed without a full leadership team and with declining membership.

I'm hopeful that this is as uncomfortable a position for the membership as it is for the leadership team. There have been spirited discussions but no real path forward other than keep on doing what we are doing. We should all realize, that will lead inevitably to the demise of NCT.

I urge you to reflect on what NCT means to you. I also urge you to step up and volunteer to be a leader on a national level.

I'm sure that this will be a topic of discussion at the National Rally July 20-25 in Orrstown, PA. I would encourage you to attend the National Rally and contribute to the discussion of where our organization goes in the future as well as volunteering to help with leadership responsibilities.

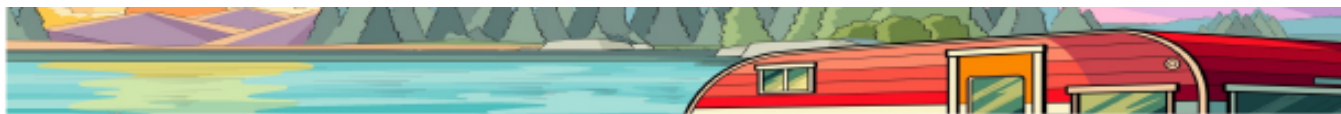
